



Poror Smith (Barrepor Concel) states the Father of the late Private is very anxious to know the spot where his son was buried, in view of the fact that possibly he may some day desire to visit the grave, and he feels that it will probably be easier to obtain accurate knowledge now of the spot while it can be ascertained definitely from some of those who know it, and who have not yet left the Country.
